### **Proposed Changes to the Constitution**

The Executive Committee of the Birkenhead Town Centre Association Incorporated Society (*Association*) propose the following changes to their Constitution to satisfy the requirements of the new Incorporated Societies Act 2022 (*Act*). These changes will first be submitted to Auckland Council for feedback and then submitted to the members of the Association for feedback.

"Act" means the Incorporated Societies Act 2022, as amended from time to time."

- 2. The rights of a person to have more than one voting right is not as clear as it could be. The existing clause 5.2 could be replaced with:
  - "5.2 For the avoidance of doubt, a natural person or one legal entity may be a Full Member only once at the same time even though that person may be entitled under rule 5.1 to be a Full Member on more than ground.

Note: This rule does not stop a person having two different legal entities who are each eligible to be a Full Member of the Association. Each Full Member could nominate the same individual to represent the two legal entities.

- 3. The Act requires an Interests Register to be maintained by the Association. A new clause 12.3 could be added:
  - "12.3 The Executive Committee will maintain a register of interests in accordance with section 73 of the Act."
- 4. The election process of the Chairperson is not as clear as it could be. The existing clause 16.1 could be replaced with:
  - "16.1 The candidates for the role of Chairperson will be nominated prior to the Annual General Meeting using the same process contained in clause 15. Each candidate for the role of Chairperson must be a Full Member of the Association.

- 5. The new role introduced by the Act of *Contact Person* is included. If the chairperson is to be the Contact Person, then new clauses 16.5 and 16.6 could be added:
  - "16.5 The Chairperson will act as the contact person for the Association.
  - Any change in the contact person or that person's name or contact details shall be advised to the Registrar of Incorporated Societies within 20 days of that change occurring, or the Association becoming aware of the change."
- 6. The Association's ability to take out director and officer liability insurance and the Association's indemnity of its Committee could be expressly recorded. New clauses 34.3 34.5 could be added:
  - 34.3 The Association indemnifies its current and former Officers, Members and employees as permitted by section 96 of the Act.
  - 34.4 With the prior approval of the Executive Committee, the Association may effect insurance for its current and former Officers, Members and employees as permitted by section 97 of the Act.
  - 34.5 The Association is authorised to indemnify an Officer under section 96 of the Act or effect insurance for an Officer under section 97 of the Act for the following matters:
    - (a) liability (other than criminal liability) for a failure to comply with a duty under sections 54 to 61 of the Act or any other duty imposed on the Officer in their capacity as an Officer; and
    - (b) costs incurred by the Officer for any claim or proceeding relating to that liability.
- 7. The reference to the Common Seal as a method of signing documents be modified, as Common Seals are no longer mandatory. The existing clause 37 could be replaced with:
  - "37.1 A contract or other enforceable obligation may be entered into by the Association:
  - 37.1.1 if a deed, by:

- (a) two or more members of the Executive Committee; or
- (b) a member of the Executive Committee, or other person or class of persons, whose signature or signatures must be witnessed; or
- (c) affixing its common seal.
- if some other form of contract or written agreement, by a person acting under the Association's express or implied authority."
- 8. A new Disputes Resolution clause 41 is added.
  - "41.1 The Association shall adopt the dispute resolution procedures as set out in the Act."
